General Business:

NZPC/NZRC meeting: All Nat Com members will have received the Memorandum of understanding. Need to follow-up Incorp Society name to ensure correct wording. (New Zealand Riding Clubs Incorporated)

Bev does not see value in this merger and will not participate in this venture

Christine explained that this document is an understanding of the commitments of each group and that we will hopefully look at exploring the feasibility of this happen with both NZRC and NZPC clubs. Pilot groups are to be established around the country offering NZPC examiners and Certificates on a voluntary basis. Possible next meeting December 2018.
